


AGREEMENT FOR SERVICES

This Agreement is made as of this the ____ day of _____, 20__ (the "Effective Date"), by and between Lin- Tech Company, an Indiana company (hereinafter "Lin-Tech") and (hereinafter "Client"), (collectively, the "Parties").

WHEREAS, Lin-Tech agrees to provide Consultation and Project Engineering services to the undersigned Client and acknowledged by the client's signature that the client also is agreeing to the conditions and terms of this agreement.

- A. **Lin- Tech works on behalf of the Client;**
 - a. All communications will be copied via e-mail, phone calls or sent by mail.
 - b. Lin-Tech will invoice the Client directly for all services and expenses.
- B. **These services may include, but are not limited to;**
 - a. Consultation and evaluation of project and methods of implementation.
 - b. Personal contact with vendor and other service providers.
 - c. Engineering assistance with Patent applications.
 - d. Engineering documentation and Computer Aided Design (CAD).
 - e. Facilitation of and/or manufacture of prototypes
 - f. Creation of specifications creation of flowcharts and software creation.
- C. **It is further understood that the Client agrees to compensate Lin- Tech;**
 - a. At the rate of \$85.00 U.S. Dollars, per hour, for efforts made on behalf of the Client. The closing date for invoices is the 25th of each month, and invoices are to be paid within 15 days of the date of the invoice.
 - b. In addition, any and all expenses incurred on behalf of the Client will be included in the monthly invoice.
 - c. Failure to pay an invoice shall be a notice to stop all work efforts on behalf of the Client. This may cause the priority of the client's project to be reduced. And future progress, if reinstated, may be delayed because other projects have moved up to fill the vacancy.
- D. **If either the Client or Lin-Tech wishes to terminate this agreement they may do so with a 15 day written notice.**
 - a. Any work in process will be stopped as quickly as permissible under the working agreements applicable with vendors and subcontractors engaged on behalf of the Client. And the Client agrees to be responsible for any and all charges incurred between giving notice and the actual termination of efforts on behalf of the client.
 - b. The Client agrees to compensate Lin-Tech for any and all costs, attorney fees and legal fees associated with the collection of any unpaid invoices as a result of this agreement.
